TRCU (EAC) – Technical Regulations of Customs Union. The Federal Law on Technical Regulation No. 184-FZ dd. introduces the definition “Technical Regulations” on December 27, 2002. The law separates the technical requirements from the legislation requirements and establishes the approach of obtaining certification to the standards by meeting the mandatory requirements for safety and health insurance for different kind of products from the technical regulations.

LIST OF TECHNICAL REGULATIONS. The three members of the Customs Union agreed on common principles and rules for technical regulation, and established a uniform list of products subject to mandatory certification procedures in the Customs Union. It was also ruled that none of the CU member-states may add a product to their respective national Mandatory Certification List, if it is not included in the Uniform list.

In the area of the Eurasian Economic Union a common customs tariff, unified trade rules and harmonized technical standards apply. The Eurasian Conformity Mark - EAC - is official proof that the products conform to all Technical Regulations of the Eurasian Economic Union (TR CU and TR EAEU) assessment procedures.

The Customs Union consists of three countries: Belarus, Kazakhstan and the Russian Federation. These countries have agreed on the sole basis of technical and regulatory rules.
